

Advocate for Affordable, Reliable Energy in Georgia

Every three years, Georgia Power updates its Integrated Resource Plan (IRP), determining how they will invest funds from their 2.7 million customers over the following two decades.

This plan largely determines which energy sources and programs are available to Georgians and at what environmental and financial cost.

The Georgia Public Service Commission (PSC) regulates Georgia Power and hears from stakeholders throughout the planning process before voting on the IRP in July. Since the Commission's decisions have far-reaching impacts on our energy future and utility costs, making public comments can be a **meaningful way to advocate for change.**

How to Access

IRP filings are publicly available in docket #56002 on the PSC website. The main filing is document #221233.

The Demand-Side Management (DSM) Plan is filed separately as docket #56003, but the main IRP docket is all that most people will need.



Comment Online

Visit psc.ga.gov/public-comments to provide comments online. Enter the docket number to ensure comments are filed accurately in the public record. If you are commenting on a specific agenda item for a bi-weekly committee meeting, you can enter it in the online form. Leave "Agenda Item" blank if you are commenting on the IRP docket generally.



Comment in Person

The public can comment during the last 15 minutes of the Commission's regular bi-weekly Thursday committee meetings. (Public comment is not allowed during administrative sessions, which are Tuesday meetings when votes are held.)

During proceedings like the IRP, the public can also comment on hearing days. Comments are heard during the first hour (9:30-10:30 a.m.), though the comment period may last longer at the Chairman's discretion. Sign in on the first floor at least ten minutes before the hearing.

Know Before You Go

- PSC meetings are held downtown at 244 Washington St., Atlanta, GA 30334 in Room 110.
- There is a parking garage at the end of Washington St. The closest MARTA rail station is Georgia State.
- Business attire is recommended.
- You will need to sign in, show your ID, and go through a metal detector.
- Speakers should see the Executive Secretary for the sign-up sheet that is provided one hour prior to the start of the meeting or hearing.
- Commenters are limited to three minutes at the podium and must conduct themselves appropriately.
- Do not have conversations you wish to remain private anywhere in the building.
